## **Acceptable Use Policy For Student Chromebooks**

### **Instructional Focus**

The Harrison School District believes that every student deserves the opportunity to better themselves through education. With this in mind, the district provides digital devices to make sure each student has every opportunity to fulfill this goal. This document is provided to make all users aware of the responsibilities associated with efficient and ethical use of Chromebooks.

### **General Information**

Student use of a Chromebook falls under the guidelines of the districts [Technology Policy](#), and [Internet Safety and Acceptable Use](#). All applications, activity, and documents stored on a Chromebook are the property of Harrison School District and subject to regular review and monitoring. The use of Chromebooks as a technology resource is an educational tool and privilege.

### **Chromebooks will be provided in every classroom throughout the Harrison Schools District**

#### **Students should:**

- Comply with teacher instructions
- Stay on Task
- Only visit appropriate sites
  - o Streaming Movies, TV, Video, and Music Sites are prohibited and blocked
  - o Viewing obscene/pornographic material is prohibited and blocked
  - o Video/Picture/Text Messaging Sites are prohibited and blocked
  - o Non-Educational Online Gaming Sites are prohibited and blocked
- Interact in a positive manner using internet etiquette
- Remember that Chromebooks are issued for educational purposes only
- Log into a Chromebook with their student email address only
- Keep the Chromebook away from food and drink
- Make sure their hands are clean before using
- Always replace the Chromebook back in the classroom cart and connect the charger when not in use

#### **Students should never:**

- Modify/damage the Chromebook in any way
- Log in to a Chromebook with a personal email address
- Use Chromebooks to charge other devices
- Remove asset tags or labels from the Chromebooks
- Gain access to another student's account, files or password is prohibited

- Remove Chromebook chargers from carts
- Commit any form of "Cyberbullying" including, but not limited to tormenting, threatening, harassing, humiliating, embarrassing or otherwise targeting another student is prohibited.

**Damage and Reporting Technical Issues**

Any errors, problems or damage with the Chromebook should be reported immediately to your teacher. By Harrison Board of Education policy, any negligent or malicious damage by a student to a device may result in the student assuming financial responsibility based on current market or part value. Students should immediately report any errors, problems or damage to their teacher, so that an incident and technology report can be filed.
